With reference to the above, I am directed to inform you that the summer vacation in all DIETs & PTTIs, excepting those in hilly areas of Darjeeling and Kalimpong districts, shall commence on and from 02.05.2022 and continue till 15.06.2022 or until further instructions, whichever is earlier, if the concerned institute does not decide on switching to online mode of classroom transactions in a befitting manner, involving all the teachers and the taught in order to combat the prevailing heat wave-condition.

The existing academic and evaluation programmes shall be rescheduled and/or reoriented accordingly under intimation to the undersigned via secretarywbbpe.ptti@gmail.com, in maintenance of continuity and consistency of the prescribed learning-teaching and evaluation guidelines, issued by this Board from time to time.

Please note that External Evaluation in P3 (School Internship including Practice Teaching), scheduled between 02.05.2022 and 15.05.2022 in terms of our Notification No. 50/BPE/D. El. Ed./2022, dated: 04/03/2022, shall have to be rescheduled after 15.06.2022 or until further instructions, whichever is earlier, under intimation to the undersigned via email. However, the external evaluators, appointed by Board, shall remain as they are.

You are, therefore, requested to take up appropriate actions in the light of the aforementioned two orders/memo.






